They have a renewable resource content of approximately 85%, are biodegradable, home compostable and compostable to European (EN 13432) and American (ASTM 6400) standards. Additionally, Plantic® trays offer anti-static and odour barrier solutions, essential for chocolate packaging.

Plush Chocolates wanted their packaging to do three things: reflect the high quality of the chocolates inside by being desirable, tasty and good-looking; show that chocolates made with Fairtrade ingredients can be just as exciting and dynamic as other products; and be ethically sound. Plantic® packaging ensured all of these requirements were upheld.
